- Eddie reflected on his history as a Board member and Congregational President. He stressed his willingness to serve the congregation in this role and usher in needed change.
- The Year in Review accomplishments and changes
 - New website launch
 - Set Board Goals
 - Adding Youth Reps to the Board
 - Beginning improvements to communications systems
 - Bringing younger members to the Board and other committees
 - Developing better recruitment processes
 - Participating in Pride events
 - Providing staff with Christmas bonuses
 - Holding the first mid-year congregational meeting
 - Updating by-laws: reshaping Board from "policy" to "strategic", updating term limits for Board officers, creating the Management Team, etc...
 - Hosting and facilitating events, such as the Chili Dinner, First Sunday Lunches, 75th
 Anniversary Celebration, etc...
 - Approving Building & Ground improvements

- The Minister's Report was provided to the Board via email. Board members were asked to contact Chris directly with questions.
 - Report is attached as Appendix A.
 - Chris reported that he felt the recent Interfaith Pride Service went very well, in addition to hosting Family Promise and FISH food deliveries during a holiday week.
 - Eddie asked Chris to report on the results of the General Assembly election. Chris stated that the updates to Article II were approved, and affirmed that the previous seven principles can still be used in responsive readings and as statements of faith. He provided documentation of the new Statement of Values, and said that they would be used as inspiration for upcoming services. Chris provided links review the GA resolutions via email (links and additional information included in appendix A).
 - Chris also asked to continue Eddie's review of the year by including the All Ages
 Prom and the KICMA Good Friday Service.
- The Management Team Report was provided to the Board via email. Board members were asked to contact Claudia directly with questions.
 - Report is attached as Appendix B.
- The Strategic Planning Committee report was presented by A.B.
 - Slides are attached as Appendix C.
 - A.B. summarized the purpose of the Strategic Planning Committee: to take an organization from its current reality into its shared future vision. Strategy execution requires servant leadership, coordinated actions for projects and processes, and progress indicators. A church executes its strategy through governance, programming, and ministry. The Board and Board Committees are primarily responsible for governance; the next Board will be tasked with developing policies and processes to ensure effective execution and resource management.
 - Heather commented that Board Committees will be a focus for this upcoming year.
 She asked A.B. to comment, and he clarified that the goal is to guide the elected committees in the right direction with policies/objectives that reflect the Board's goals and develop membership within those committees.
 - Heather also clarified that the Board will be breaking for the rest of the summer,
 with a retreat scheduled in August, and will proceed with this strategy in September.
 - A.B. stated his pride in the work that the Board has done this past year. Heather expressed her appreciation for the work of the SPC in supporting and guiding that work.
- Incoming President Heather made a statement about the upcoming year.
 - Our structures and systems are all on their way to being completed with lots of input.
 - We will continue to strengthen our groups with policies and charters,

- Improved communication paths will be developed for groups that interact with folks entering our building.
- When we see something that needs improvement, it is our job to help create a process or policy to create the change that we want.
- Heather also wants to strengthen our relationship with our UU neighbors in the East TN area.
- The focus this year will be to put into play the things we have been talking about all year.
- The floor was opened for a Q&A session.
 - Chloie mentioned options for open communication, such as the red book we used to have at the fireplace.
 - Jeff believes we've done a great job at welcoming people who walk in the door, but we need to work on new ways to bring in new members.
 - Heather mentioned a goal of advertising our church as a meeting space beyond UU events (such as forums).
 - Maddie reminded the Board of the importance for Board Members to volunteer in RE spaces. Chris and Heather concurred.
 - Carol states that sometimes it is an experience not a person that brings a person to the congregation, like her teenager running the dishwasher in the kitchen. Chris added that he wants to be intentional with our programs and service programming around helping everyone find their gift.
 - Details of the Board retreat were discussed.
- Heather read closing words, recognizing the Board Members leaving and welcoming the new Members. The meeting was adjourned at 7:00 pm.


