Minutes for the Annual Congregational Meeting of the Tennessee Valley Unitarian Universalist Church, June 11, 2023

1. Call to Order

Having observed that the audience present constituted a quorum, Ken Stephenson, TVUUC President, called the meeting to order at 12:35 p.m. (photos available for verification)

2. Confirm Covenant [4:56]

Ken Stephenson read the covenant expressing the points in Chris Buice's sermon of this morning reinforcing the points for the best ways to work together in covenant as expressed in the RE manual: 1) show respect for all, 2) be kind and fair, 3) participate and encourage each other, 4) share and take turns, 5) include everyone, 6) settle disagreements in peaceful and caring ways, 7) take care of each other, our space and our world, 8) challenge racism and oppression wherever we find them. At this point, the chalice was lit to begin the meeting. [6:23]

3.Motion to allow virtual voting [6:53]

Ken announced the motion to permit virtual voting, which is necessitated by multi-platform participation, including in-person and on-line (e.g. ZOOM) presence. He noted that this motion will be integrated into the Church by-laws for future Congregational Meetings.

"We, the members of the Tennessee Valley Unitarian Universalist Church, vote to henceforth hold all called congregational meetings simultaneously, in-person and virtually. All votes by members in such meetings will be valid, just as if we were all meeting in-person in the Church space. Our Church is not the building itself, but the people of which it is made."

He called for a vote on this motion by a show of hands.

Motion carried unanimously. No opposed. No abstentions. [7:59]

4. Approval of minutes from June 2022 Congregational Meeting [8:36]

The minutes for the Congregational Meeting on June 22 have been on-line for some time. Ken called for additions, corrections or comments to the minutes as posted. Seeing none, he noted that the Meeting Ballot contained a line for the approve of these minutes and that the tally would be made available when all votes on the Ballot were counted.

The detailed budget, available on request from Claudia Pressley, contains for each line item, the proposed and the current dollar figure. [22:59] This proposed budget was developed by the Finance Committee, with input from the staff and the Personnel Committee and was approved by the Board in its last meeting of May 7 for presentation to the Congregation.

Revenues for this coming year are only \$17,000 greater than the current budget, largely because pledge revenues have remained substantially flat. Non-pledge revenues are based on historical numbers in these categories, though with the end of COVID restrictions, Sunday plate contributions should rise as attendance increases. Eddie reminded the Congregation of the continuing opportunity to establish or increase pledges if that has not already been done. This opportunity is always available during the year. A Fund Raising Task Force is being organized to help realize the ambitious fundraising goal budgeted. In addition, proposals to increase membership should help realize revenue projections. The RaiseRight gift card system should also contribute to a rise in revenue. More information on this opportunity for the church will be forthcoming. [25:13]

Expenditures: The greatest proportion of expenditures by far is for salaries and other personal expenses. These expenses are increasing by about \$60,000. We increased the pay for sextons and childcare personnel to \$15/hr in the hopes of maintaining our ability to attract and keep quality employees. There was a 7% increase in salaried positions, but that unfortunately did not meet the recommended 14% cost-of-living increase the Personnel Committee recommended. Leadership will continue to look for ways in which additional adjustments can be made. Capital expenditures are pretty straightforward with the money coming from the existing Capital Reserve Fund including some unspent monies from capital budgets in recent past years. The proposed expenditures are on most everybody's wish list: parking lot resurfacing, HVAC replacement, office carpet. Final decision on these items will come from the Building and Grounds committee.

Eddie then opened the floor to questions. Beauvais Lyons asked about the number of pledging units now and in the recent past.

Actual count: 203 pledging units of about 373 members. The number of pledge units is roughly the same from recent years. The structure of pledging is *top heavy*. Approximate 25% of pledge units account for about half of our budget, most of them over the age of sixty. [28:45] Grier Novinger asked about available COVID relief loans. About \$80k is still available from the original \$149k loan. The service fees and interest are modest about \$640/month repayment. Gene Burr asked about maintenance and other expenditures in relation to the solar panels on the roof. Ken Stephenson noted that we have a special earmarked fund for the solar panels from which the panels have now been paid off. About \$7k remains in that fund to cover ongoing expenses. Ken added that the SBA loan covered about \$50k of badly needed re-roofing expenses to fix the leaks that had plagued the church. Interest is a little less than 3%. [32:33] We can earn 5% in CDs until we have settled on specific projects. Elnora Williams asked about some of the creative aggressive fund raising ideas that have been mentioned. Ken expressed eagerness to hear suggestions. The Rummage Sale and Auction were examples of past ideas from members. Currently they bring in about \$5k down from earlier years of \$25k. He gave the example of using RaiseRight on his phone and got a 4% donation from Home Depot (or Lowe's) on his purchase at no cost. This is something like the gift cards at our table in McKendry Hall, but with hundreds of available merchandisers available. LL Bean does 14%! **We pay no more, the seller gives us a cutback.**

The meeting paused again for casting ballots and eating pizza, possibly in that order. [36:29]

As members prepared to vote, David Massey discussed the background for proposed changes in the Motion on the Endowment Fund Charter. The Endowment Fund Committee is charged with balancing the fiduciary responsibility of maintaining the integrity of the funds and funding legitimate projects outside the scope of the annual church budget. In light of recent market declines, one portion of the formula for calculating recommended distributions has proven to be unnecessarily restrictive. Massey noted that both the EFC and the Board recommend that the Congregation adopt the amendment deleting the "Adjustment for Market Declines" provision in Article III of the Charter. Without this provision, the "rolling average" formula in Article III will still account for market fluctuations, while also factoring in the impact of new donations. Moreover, the rolling average formula is in line with best practices observed in other well run endowment funds, e.g. the East Tennessee Foundation. With the proposed change, the Board must still approve distributions for projects and programs. He then opened the floor to questions. In response to a question about the current fund status, he gave it as \$780,000 as of close of business on Friday, June 9, 2023. He noted for information that the passage of the proposed changes requires a 2/3 majority to be accepted. [42:13]

To confirm that the Congregational Meeting was in fact operating under the **quorum of 50 members**, Ken asked that this be determined by unanimous consent, **which was approved.** [48:02]

The meeting reconvened. [52:34] Ken reminded those present that the gift card table remained open for those interested and that even as the RaiseRight option was coming into use, the gift card table would continue to function as before. [53:05] In response to a question, Ken clarified that if one's Raise Right account was linked to one's bank account, then the transaction cost was minimal, around twenty-five cents, whereas the credit card procedure incurred somewhat larger costs.

7.Report on the Endowment Fund - David Massey

David began his report of the Endowment Fund Committee by stating that it was available in two forms. The first is a two-page summary which had been distributed here in the Sanctuary this morning. Online members could see a copy of this report by emailing him at EndowTVUUC@gmail.com for a copy.

The second part of this report are the actual financial statements for Calendar Year 2022 and the first quarter of 2023. Again, any member of the Congregation can email <u>EndowTVUUC@gmail.com</u> to receive a copy of these statements. David said he would also be available to respond to any questions or concerns after this meeting, or

in the days ahead by calling him directly at 865-621-8352.

Report for the full calendar year 2022

As of 12/31/2022, the Fund's ending balance was \$569,522, down \$107,563 from 12/31/2021. Donations totaled \$14,285, down from \$31,825 in CY 2021, and \$76,877 in CY 2020.

- The Vanguard accounts suffered an unrealized market loss of \$122,117 offset by dividends totaling \$14,644.
- During CY 2022, the Fund provided \$18,281 for five projects including the lobby monitor set up by Beauvais Lyons and Ted Jones that scrolls photographs and videos of TVUUC members and activities.
- These projects also included the cameras and lighting needed to livestream this meeting and all Sunday services.

January-March 2023

Donations to the Endowment Fund in the first quarter totaled 170,377 — due in large part to gifts from Jamie Adcock and from the estate of Kim Haynes.

Apart from donations, the Fund has not recovered from the substantial losses suffered during 2022, but during the first quarter the Vanguard accounts did show an unrealized gain of \$30,609 and income returns of \$268. With the latest donations, the Fund's ending balance was \$770,775 compared to \$638,511 on March 31, 2022.

Within the parameters imposed by market cap provision in the Endowment Fund Charter, the EFC allocated up to \$7,075 for three projects in 2023 - a community garden water system (\$475), worktables for the community garden (\$600), and facilitator training for the Our Whole Lives (OWL) sexuality education program (\$6,000).

As of close of business Friday, total assets have reached a high water mark of \$781,386 – more than double the \$375,000 that was in the fund in early 2020.

Again, the gain since December is due in part to the market clawing its way back from the debacle of 2022, but mainly because of the two large gifts previously mentioned.

But, in fact, all gifts are important and have an incremental benefit to the growth of the Fund, and to our ability to support special projects. As Marion Von Beck says, every little bit helps, and many bits add up to a lot. Thank you to everyone who has made gifts to the fund and who have included the Fund in your Wills.

He concluded with a special shout-out to Gail Anderson who is cycling off the committee this month after

serving a 3-year term. We will miss her on the committee and wish her well. [59:45] He opened the floor to questions, but there were none. [59:58]

He reminded the congregation that the new cycle for proposed projects will begin with requests for proposals when it resumes its work in October, 2023. Decisions on these proposals for calendar year 2024 will be made in January, 2024 by the committee, then transmitted to the Board for final approval after which the funds can be made available. [60:44]

8. Report on the Eighth Principle Task Force - Mark Mohundro

Mark began by refreshing people's memories of the wording of the Eighth Principle: "We covenant to affirm and promote: journeying toward spiritual wholeness by working to build a diverse multicultural Beloved Community by our actions that accountably dismantle racism and other oppressions in ourselves and our institutions."

He then listed important milestones from this past year.

- 1 Dedication of the Elandria Williams' Room
- 2 September 4th Service-Ableism and Disability Justice by Rob Spirko
- 3 Help producing the October 16th Service-Diwali
- 4 February 25th Workshop- Abundant LUUv and the 8th Principle of Unitarian Universalism -Featuring Rev. Duncan Teague
- 5 February 26th Service- At the Boundaries of Our Love and Faith--Rev. Duncan Teague

Upcoming events this year will include the UUA Common Read Program entitled "Mistakes and Miracles: Congregations on the Road to Multiculturalism." The UU Common Read builds community in our congregations and our movement by giving diverse people a shared focus for reflection and action. A Common Read can take us on a powerful faith journey into what it means to be human and accountable in a world filled with both pain and joy. It shares how five diverse congregations encounter frustrations and disappointments, as well as hope and wonder, once they commit to the journey to create multicultural, antiracist Beloved Community.

Sometime in September there will be a six-session webinar called "Trans Inclusion in Congregations" focusing on transgender inclusion in congregations.

He reminded the congregation that the Eighth Principle encompasses <u>ALL</u> forms of oppression, such as women's rights.

Other plans include a field trip to Cherokee, NC, a field trip to The Legacy Museum in Montgomery Alabama: "From Enslavement to Mass Incarceration" as well as more services on additional topics.

In conclusion, he thanked the members on the committee for the valuable assistance: Elnora Williams, Chloie Airoldi-Watters, Patsy Farmer, Seema Singh, Mary Rogge, and Eddie Chin. Additionally, he recognized with gratitude the work of Ken Stephenson, the Board, Catherine Farmer-Loya, Chris Buice, and David Massey for funds to support Rev. Duncan Teague's workshop and service [66:14]

To address an earlier inadvertent omission, Ken announced the appointment of Doug Cox as Chair of the Personnel Committee.

Introducing the co-chairs for the Program Council, Ken announced that the Program Council will now be headed by co-chairs, Barbara Lamm and Betty Bumgarner, because it is a big job requiring the services of two

people. They were greeted with enthusiastic applause. [67:13]

9. Report from the Program Council - Barbara Lamm and Betty Bumgarner

Barbara reviewed the renewal of the Program Council's activities following COVID, featuring the successful Homecoming Event. Program Council has resumed regular meetings on first Monday of every month, to which all are invited. There are currently forty-seven (47) programs and three additional ones will soon be added. Three youth programs have been supported: Let's Connect, Garden Club, Nature Exploration. Betty and Barbara emphasized the need for volunteer sponsors to keep programs functioning well. [71:19] The Program Council supported the refurbishment of the Linda Kraeger library and shelve the many book donations. The Alliance also provided funds and help in this endeavor. The Program Guide covering all these activities will be made available soon. [74:09]

Ken then opened the floor to questions and comments. The RE Program came in for great appreciation. [76:02]

10. Recognitions

Ken expressed thanks to the staff and host of volunteers whose collective and cooperative efforts keep the church and its programs running. He urged members who may be looking for something to do to reach out to committees and task forces such as Buildings & Grounds, Strategic Planning, Finance, Leadership Development, Endowment Fund, Technology Task Force, Eighth Principle, Reproductive Justice, Fund Raising Task Force, all of which are looking for new blood, active support and fresh ideas. He expressed deep appreciation of all the members who already spend their time and energy to do this valuable work. [77:27]

11. Recognition of Incoming Board Members and Thanks to Departing Board Members

Ken thanked Board Members Ryan McBee, Linda Randolph, Wendy Syer, and Alice Woody. His words of gratitude to Chris Buice, Claudia Pressley, Catherine Farmer-Loya, Miriam Davis, Michael Miller, John Montgomery, Mark Mohundro, and David Asbury were greeted with a round of applause.

A request from the floor suggested that additional information on the Stewardship Campaign would be desirable with such information as number of pledge units and pledge levels because of the impact that has on the budget. Ken reported that the Board would be considering that issue. [82:56]
